


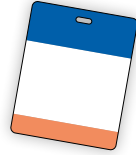

# Ticket types and access

## Exhibitors

Exhibitor staff will manage your stand and any additional meeting space.



All exhibitor staff must register using a link and unique web registration code ending in /EX sent by the client services team. If you have not received these details please email them directly.

### Additional exhibitor passes

The email from our clients services team will outline how many additional discounted exhibitor tickets you can purchase. Once you have exceeded your allowance, you will need to purchase "access all areas" delegate staff tickets at your discounted rate.

### Session access for exhibitor staff

Please note that speakers will be automatically registered by our programming team. Speaker tickets do not come out of your ticket allocation.



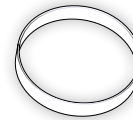
## Suppliers

Onsite exhibitor suppliers (for example baristas) cannot be company employees. Suppliers must be registered by you, online, before the event.



## Stand builders

All stand builders must be allocated and wear a wristband onsite at all times. These can be collected onsite from our operational team.



The wristband grants pre-event access and day 1 access between 7am-8am only. Prior authorisation will be needed after 8am and stand builders must be accompanied onto the exhibition floor.

## Venue host staff

All host staff that are hired directly through Bella Center will need to wear a numbered clip and pin badge which can be collected from the registration desk. Host staff only have access to the exhibition floor and meeting rooms. No access to sessions or food/beverages.
